- 5. Electronic bids must be submitted to Triveni Rural Municipality Office, Luham, Salyan through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM as mention in below. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13: PM as mention below at Triveni Rural Municipality Office, Luham, Salyan. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 1,30,000.00, which shall be valid for 30 days beyond the validity period of the bid as mention below.
- 7. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
